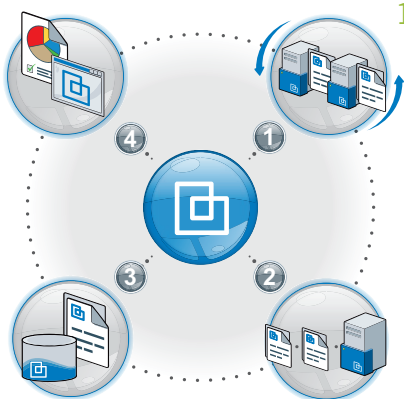

1. **Collect** - a data snapshot from each Lumension Patch and Remediation™ server in the environment, on a pre-defined, automated basis.
2. **Upload** - data to a separate Enterprise Reporting server, via secure RSA encrypted transmissions.
3. **Consolidate** - the data into the central Enterprise Reporting data warehouse repository.
4. **Report** - analyze the centralized data with drill down capabilities.

Key Features

Auto Report Generation and Distribution: Schedules automated report generation and immediate email distribution of reports to authorized users.

Comprehensive Pre-Defined Report Library: Delivers 29 standard reports for vulnerabilities, patch deployment, configuration, inventory and compliance. Reports are not fixed and may be extended to meet organizational needs.

Efficient Data Consolidation: Views current status of vulnerability management efforts with up-to-the-minute reports.
